This memorandum of understand (MoU) is made in Mardan on the 26th day of March 2021

Between

The **Khyber Medical University** (herein after to as the **KMU**) of the first part

AND

Bacha Khan Medical College (BKMC) of the second part.

WHEREAS recognizing that mutual scientific and technical co-operation will advance the state of science and technology within both partners and strengthen the academic infrastructure and will bring benefits to both sides, do hereby agree to cooperate in future.

Khyber Medical University, Peshawar and Bacha Khan Medical College Mardan & its allied health sciences, undertake to pursue a program of Academic, Research, scientific and technical collaboration for the exchange of ideas, skills and techniques on problems of mutual interest as agreed from time to time.

NOW, THEREFORE, both parties have entered into the memorandum of understand on the following terms;

1. Exchange and training of scientific and technical personnel for teaching, research and development in the field of Public Health, Basic sciences, clinical sciences, nursing, medical lab technology, Epidemiology and Biostatistics and other related fields pertaining to the interest of both parties.
2. Joint or cooperated scientific research and technological development projects/programs in the selected areas of mutual interest. The faculty of BKMC can hold the position of PI or Co-PI in the projects developed jointly and agreed by both parties. However, the funds disbursement/imbursement will be managed by KMU-ORIC fund account.

3. Holding of joint conferences, seminars and symposia or workshops and invited lectures on national and international issues.
4. Joint supervision of research related activities in the areas of mutual interest.
5. Visit and utilization of each other's research and technical facilities as and when required after mutual consent. The BKMC will give access of its clinical resources (patients and data) to KMU students and faculty for research projects purposes whenever desired and agreed upon by both parties and both parties will keep the patients confidentiality.
6. The BKMC will develop a research cell in the premises of the institute for close liaison with the office of research innovation and commercialization KMU.


The MoU will remain effective for a period of ten years unless terminated by any one of the partner by giving advance notice of six months. Both parties will appoint liaison officers who hold periodic meetings to work out the details of cooperation on such terms and conditions as agreeable to both the parties and to monitor their implementation and prepare annual progress reports.
